## Malibu Council defers mobile home rent control changes amid fierce opposition

The Malibu City Council voted Monday to defer proposed amendments to the city's mobile home park rent stabilization ordinance after overwhelming public opposition and a contentious

dispute between city staff and a newly reconstituted commission.

The decision came after more than 90% of the approximately 150 attendees packed City Hall specifically for the agenda item, with 41 residents signing up to

## Westside incumbents draw challengers in Los Angeles supervisor and council races

Challengers have stepped forward to take on two Westside incumbents in 2026, with a Palisadian filing against Los Angeles County Supervisor Lindsey Horvath and two candidates

(a civil rights attorney and an entrepreneur) lining up against City Councilwoman Traci Park.

The early filings set the stage for contested races in two of the region's most closely watched seats, testing whether incumbents who took office in 2022 can hold on as voters weigh concerns over housing,

homelessness, public safety and emergency response.

Candidate filing opened this week for the June 2 primary in Los Angeles County's Third Supervisor District, and Horvath immediately drew a challenger.

# New Roads ready to continue revitalized baseball dominance

The Jaguars are led by seniors Xavier Walker, the 2025 Coastal League MVP and undefeated pitcher in league play; Ellio LaPorta, a two-time league MVP in 2023 and 2024 who missed most of last season with a broken thumb; and center fielder Asamino Spong, who led the team in stolen bases.

The trio helped transform a program that went 1-41 over four years before their arrival into a dominant force with a 16-4 league record and three championships.

Sophomore Matthew Linares, the league's MVP runner-up last season, returns as a two-way contributor, while seven juniors led by Santiago Jimenez and Sebastian Berumen add depth to the roster.

"This is by far the most talented, disciplined team I've ever coached," head coach Hector Zamora, a former New York Yankees prospect, said.

New Roads is a private K-12 school in Santa Monica serving approximately 525 students.

# Hospitals' opaque pricing is crushing California's small businesses

Small business owners are working hard to keep their doors open while offering employees quality benefits, but rising healthcare costs are making that harder every year.

One major driver of these costs is hospital pricing abuse, which often goes unnoticed but is devastating to California's small business communities.

Large hospital systems have used their market dominance to drive up the prices they charge commercial payers, often billing them more than three times what Medicare pays for the same care.

Those inflated costs fall squarely on the shoulders of small businesses and working families through higher premiums and lower take-home pay.

For many small business owners, offering health insurance is already one of their biggest expenses. Nearly half of small businesses in a survey by Small Business Majority say rising healthcare premiums place a major financial burden on their business. Two-thirds say it is at least a moderate burden.

When hospital bills keep rising, it becomes nearly impossible for small firms to continue providing coverage to their employees. While entrepreneurs want to do right by their workers and offer robust health benefits, they are often forced to make painful choices about wages, benefits and business growth as premiums skyrocket each year. These decisions don't just impact employees — when small businesses reduce benefits it can cost them top talent.

Rising hospital bills persist in part because hospitals block the transparency that drives competition and consumer choice. Hospitals often hide the true cost of care behind opaque billing practices and gag clauses that keep employers from seeing what they're actually paying.

And, according to Small Business Majority's research, as many as 58% of small business owners have had hidden "facility fees" tacked onto their hospital bills. These fees allow hospitals to charge more for the same services if they are provided in a facility owned by a hospital, instead of an independent clinic.

Meanwhile, hospitals across the state

have continued to consolidate and swallow up local providers, reducing competition and giving large systems unchecked power to dictate prices. Market consolidation through hospital mergers ultimately drives up healthcare costs for consumers — including small businesses.

According to RAND Health Care, hospital mergers have resulted in estimated price increases ranging from 3% to 65%.

With fewer competitors, healthcare costs rise without a corresponding increase in quality of care. In fact, consolidation can lead to a higher mortality rate and more major health setbacks.

Rural communities are particularly vulnerable to the negative impacts of healthcare mergers, as they're more likely to experience larger-than-average price increases, often in outpatient services. Additionally, rural merged hospitals are more likely than rural independent hospitals to eliminate crucial services like maternal, neonatal and surgical care.

California's regulators are already playing a role in helping bring down prices. The California Office of Health Care Affordability was established in 2022 to lower hospital costs and promote greater transparency. It must not be deterred when hospitals refuse to lower prices or explain their pricing structure.

We also need to see action on the federal level. During his first term, the Trump administration issued rules intended to increase price transparency and bring down costs. This was a great start but clearly much more is needed to help make the cost of care more affordable for small businesses.

Small businesses are the heart of our economy, accounting for more than half of new jobs nationwide and employing 7 million Californians. But they can't thrive if healthcare costs keep rising. Addressing hospital pricing abuse is essential for keeping California's small businesses strong and ensuring every worker can access quality, affordable care.

# Troubled LA Mayor Karen Bass faces a re-election challenge from the city's left wing

The ever-changing array of political figures seeking to become California's next governor has a doppelganger in the game of musical political chairs being played in Los Angeles over electing a mayor.

In a sense, that should not be surprising because Los Angeles, population 3.9 million, is a microcosm of California and its multitude of daunting socioeconomic, cultural and political issues.

In fact, as I described in a chapter of a 2008 book, *The New Political Geography of California*, the rapid conversion of Los Angeles and environs from decades of semi-conservative political orientation into a blue bastion during the 1990s was a major factor in California's overall metamorphosis.

The end of the Cold War, which decimated Southern California's defense industry, surging immigration from Latin America and Asia, and the development of a strong union movement all contributed to the city's leftward drift.

Thus, the issues facing the next governor — such as high costs of housing, utilities and other necessities, homelessness, uncertain water supplies, lagging educational attainment, an epidemic of wildfires, insurance gaps and budget deficits — also afflict Los Angeles and its mayor.

The current mayor, former state legislator and congresswoman Karen Bass, has shown a remarkable tendency toward political self-destruction.

A year ago, Bass left for a junket to Africa with Los Angeles facing the threat of destructive wildfires that became horrendous reality. More recently, the Los Angeles Fire Department report on the fires was watered down to protect officialdom from criticism and that Bass was complicit in the revisions.

Citing sources, Times reporters wrote that Bass "wanted key findings about the LAFD's actions removed or softened before the report was made public."

Those lapses of judgment should be fatal to Bass' re-election but one-by-one, potentially heavyweight opponents bowed out.

Initially, businessman Rick Caruso,

who had waged a credible campaign against Bass in 2022, seemed to be a likely candidate, sharply criticizing Bass on how she handled the city's worst-ever emergency. He weighed either challenging her or running for governor, but ultimately decided against both.

Austin Beutner, former superintendent of Los Angeles schools and one-time CEO of the Los Angeles Times, announced his candidacy and then dropped out, citing the recent death of his 22-year-old daughter.

Los Angeles County Supervisor Lindsey Horvath briefly considered dropping in after Caruso and Beutner dropped out, but demurred, seemingly giving Bass the luxury of re-election without a potentially potent opponent.

However, on Saturday, just three hours before the deadline, City Councilwoman Nithya Raman, declared her candidacy.

Raman, one of the council's most left leaning members, a progressive in the mold of New York Mayor Zohran Mamdani, had previously endorsed Bass when it appeared she would face a relatively conservative opponent. However, with the field almost clear, she decided to see if Los Angeles, the nation's second largest city, might go the way of Gotham.

"I have deep respect for Mayor Bass," Raman told the Los Angeles Times. "We've worked closely together on my biggest priorities and her biggest priorities, and there's significant alignment there. But over the last few months in particular, I've really begun to feel like unless we have some big changes in how we do things in Los Angeles, that the things we count on are not going to function anymore."

Given Bass' low standing in polls for her missteps on the firestorm, Raman poses a serious threat to the mayor's re-election and could compel the business community and critics such as Caruso and Beutner to help Bass fend off a challenge from the left.

The duel over the mayoralty of Los Angeles could surpass the campaign for governor to become the year's most interesting and important contest.

# Housing advocates still waiting for state-ordered stair report

In the fall of 2023, the California Legislature tasked the state's fire safety regulators with writing a report that some housing affordability advocates say could make it easier to build bigger, airier and better lit apartment buildings in California's housing-strapped cities.

The Office of the State Fire Marshal was given until Jan. 1, 2026 to come up with a report on single-stair apartment buildings — a type of mid-sized multifamily development legal in much of the world, but effectively banned across most of North America.

More than a month later, single-stair advocates are still waiting on that report — though a draft version obtained by CalMatters hints that the office may be considering a modest change to the state building code.

we will publish the report as soon as it is approved for publication," said Wes Maxey, CAL FIRE's assistant deputy director of legislation, in an email. He would not say when the report is expected to be released or what the hold up is all about.

The state legislature regularly assigns research reports of this kind to various corners of the state bureaucracy — and, as CalMatters has reported before, the state bureaucracy regularly blows past its assigned deadlines.

But the single-stair analysis has garnered considerable interest outside of Sacramento.

Current rules in California (with the one, recent exception of Culver City) require apartment buildings higher than three stories to have at least two staircases connected by a hallway.

The Legislature was clearly interested in raising that height limit when it ordered the report in the first place.

"Many European countries allow buildings with single staircases and have better records on fire safety than the United States," said Assemblymember Alex Lee, a Milpitas Democrat, urging a "yes" vote on his bill in the summer of 2023. "I believe having the Fire Marshal conduct the study will start the conversation about leveraging existing fire and emergency response technologies and strategies to maximize housing projects."

Local fire marshals, fire chiefs and fire fighting unions have, by and large, opposed easing staircase requirements in the building code wherever they've been proposed.

The final report is likely to disappoint either those organized fire services, a politically powerful constituency, or "Yes In My Backyard" advocates that have found an ally in Gov. Gavin Newsom.

A draft version of the report circulated among stakeholders in late October included a half-hearted endorsement of a change to the state building code. If the State Fire Marshal recommends new policy, the draft reads, the change should only be from a three-story maximum up to four. Any new four story single-stair structures should also be restricted in size and abide by a number of other added safety-oriented restrictions, the report added.

Culver City, west of downtown Los Angeles, passed a single-stair ordinance last year to nix the second-stair requirement in certain apartment buildings up to six stories. Six stories is also the cut-off in the four other jurisdictions that go above three: New York City, Seattle, Honolulu and Portland, Oregon.

The draft report, which is not final, also went out of its way to emphasize "the near unanimous feedback from California Fire Departments who are opposed to permitting single-exit stairway construction ... greater than 3 stories."

Whenever it is finalized and published, the report won't have the force of law. But should state legislators opt to take up the issue in the future, its final recommendations are likely to carry weight with undecided lawmakers.

"They were given a deadline," said Stephen Smith, founder of the Center for Building in North America, which advocates for cost-reducing changes to building regulations.

That safety-minded code is meant to provide residents with multiple escape routes in the event of a fire. But it has also become a focal point of criticism among a growing number of housing advocates, architects and urbanists, who say it raises the costs of multifamily construction, limits where apartments can be built, pushes developers toward darkened studios and away from family-sized apartments and provides limited health and safety benefits.

"I know there's been a real desire among politicians in California to change the state's image as a slow moving state, but in this case I don't see it," said Smith, who was also a member of the working group of fire service professionals, building code experts and housing advocates tasked with writing the first draft of the report for the state Fire Marshal. The group's last meeting was on November 4.

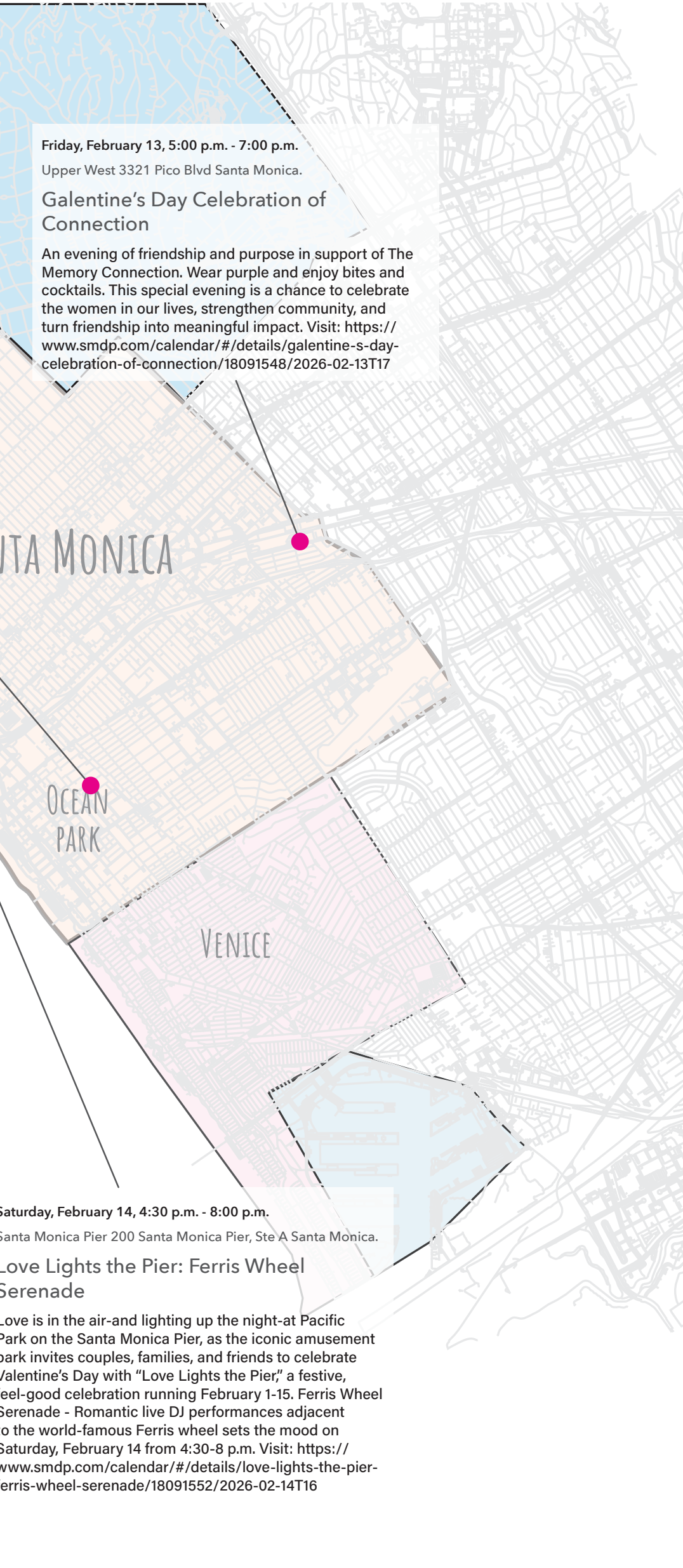

Tonia Arey filed to run against Horvath, saying the Pacific Palisades fire and its aftermath were a breaking point — not just because of the devastation, but because of what she called irresponsible and negligent handling by those in power. Arey pointed to Malibu businesses still struggling to recover, contaminated beaches strewn with debris and Calabasas being turned into a dumping ground for toxic waste, saying it didn't happen by accident but was allowed to happen and approved by the current district supervisor.

Horvath is seeking a second term representing a sprawling district that covers large stretches of the San Fernando Valley and runs along the coast from Santa Monica to Malibu. She was first elected in 2022 and is eligible for up to three consecutive four-year terms under county rules.

No Los Angeles County supervisor has lost a reelection bid and Horvath is widely expected to pursue the new voter approved county chief executive position that will be created in 2028.

The filing window runs through March 6. To get on the ballot, candidates must submit nomination papers with 20 to 40 valid signatures from district voters and pay a filing fee of roughly \$2,447, or offset that fee by collecting signatures during a designated period that closed in early February.

The county race is nonpartisan. If no candidate wins a majority in the June primary, the top two advance to a Nov. 3 runoff.

Countywide, filing also opened for an open First District seat, with Supervisor Hilda Solis barred from running again due to term limits. The June ballot will also include a sheriff's race and other countywide offices.

In Los Angeles City Council District 11, the candidate field is set after the filing window closed at noon Saturday.

Park filed to seek a second term representing communities including Brentwood, Del Rey, Mar Vista, Pacific Palisades, Palms, Sawtelle

and Venice. Civil rights attorney Faizah Malik and entrepreneur Jeremy Wineberg, a Pacific Palisades resident, filed paperwork to challenge her.

Candidates must now file nominating petitions by March 4 to qualify for the ballot. The city charter offers two paths: pay a \$300 filing fee and submit petitions with at least 500 valid signatures from district voters, or forego the fee by gathering at least 1,000 valid signatures.

Like the county race, city elections are nonpartisan. A candidate who wins more than 50% in the June 2 primary is elected outright; otherwise the top two advance to the November runoff.

District 11 encompasses a large portion of the Westside, stretching from Pacific Palisades down the coast to Los Angeles International Airport and inland to areas including Westchester and West Los Angeles. The district has seen intense debate over homelessness, particularly in Venice, along with development and quality-of-life concerns.

Park won the seat in 2022 and is finishing her first of a possible three four-year terms. Candidates were required to establish residency in the district by Jan. 3.

Across the city, the filing deadline also set the field in other odd-numbered council districts. Two open-seat contests emerged: District 3, where Bob Blumenfield is term-limited and five candidates filed, and District 9, where Curren Price is term-limited and 12 candidates entered the race. Price, 75, is facing public corruption charges, has pleaded not guilty and is scheduled to be arraigned March 13.

Other incumbents filed to run again, including Eunisses Hernandez in District 1, Katy Yaroslavy in District 5, Monica Rodriguez in District 7, Hugo Soto-Martínez in District 13 and Tim McOskey in District 15, with challengers filing in each district.

speak in person and many more submitting emails opposing the proposed changes.

"I think it's fair to say that we maybe got two or three emails at most in support of this proposal and everyone else and there were many, many of them were opposed," Mayor Bruce Silverstein said.

The controversy centered on conflicting proposals to update the city's Mobile Home Rent Ordinance, originally adopted in 1991 and amended in 1994 following federal litigation. City staff presented amendments intended to modernize language while maintaining the core rent control framework, including Consumer Price Index caps of 2% to 5% and 15% vacancy increases.

However, the Mobile Home Rent Stabilization Commission — dormant from 2008 to 2025 — had spent months developing its own sweeping changes that staff argued went far beyond the commission's authority.

Council members and staff countered that the commission, designed as a quasi-judicial body to hear rent disputes, had overstepped by drafting legislative regulations.

"They commenced to draft their own changes to regulations and the mobile home ordinance," said Councilmember Doug Stewart. "Heavy emphasis on regulations even though the staff and the city attorney advised them that they were outside their authority and were even violating the Brown Act."

Residents from Point Dume Club and

Paradise Cove mobile home parks delivered a unified message: leave the current system alone.

"If it isn't broken why are we fixing it," one resident stated, echoing a sentiment repeated throughout the evening.

In a rare alignment, park owners agreed with residents. Representatives for both Paradise Cove and Point Dume Club (operated by Hometown America) opposed any amendments, with their attorneys warning that adopting the commission's changes could invite litigation over unconstitutional property takings.

Much of the public comment focused on California Assembly Bill 768, pending state legislation that many feared would strip local rent control protections. While council members clarified they cannot control state law, they acknowledged residents' concerns.

"There is a state law proposal that we do not have control over," Silverstein said. "We can oppose it until we're blue in the face, but as of right now it passed the assembly with flying colors."

AB 768 initially proposed exempting mobile homes not occupied by owners for at least 30 consecutive days from rent stabilization. The bill was amended in January 2026 to cover "permanent housing" under rent stabilization while exempting only seasonal vacation homes and short-term rentals. As of Jan. 20, the bill passed the Assembly and moved to the Senate.

Council members criticized both the commission's process and the rushed timeline.

"What have we done here? I mean this is the absolute worst thing that can happen from a city council or from any city government where we're forcing people to make economic decisions in a fear setting," Stewart said.

Councilmember Steve Uhring warned that amending the ordinance could eliminate existing statute of limitations protections, opening the city to lawsuits from park owners.

Mayor Silverstein noted the process had gone "off the rails" by bypassing the council's ad hoc committee.

The council ultimately passed three motions: directing the ad hoc committee to advocate against AB 768, removing the ordinance amendments from the calendar and referring the matter back to the ad hoc committee for further study with public input, and rescinding all regulations enacted by the commission after June 1, 2025.

"Usually this city takes it too slow, I hear complaints, but now we're going too fast. So let's slow it down, take our time," said Councilmember Haylynn Conrad.

The mobile home parks provide affordable housing for dozens of families in one of California's most expensive coastal communities, where rent control has been in place for more than three decades.
