

**AMENDMENT TO THE AMENDMENT IN THE
NATURE OF A SUBSTITUTE TO H.R. 6498
OFFERED BY MS. WILSON OF FLORIDA**

Add at the end the following:

1 SEC. 5. PROHIBITIONS.

2 (a) PROHIBITION AGAINST USING ECONOMY ACT
3 AUTHORITY TO TRANSFER ACTIVITIES.—Notwith-
4 standing section 1535 of title 31, United States Code
5 (commonly known as the “Economy Act”), the Secretary
6 of Education shall not use the authority described in such
7 section to place an order with another Federal agency for
8 goods or services described in the amendments made by
9 this Act, or related to authorities, functions, or services
10 described in the amendments made by this Act.

11 (b) PROHIBITION ON INTERAGENCY AGREEMENTS.—
12 Notwithstanding any other provision of law, the Depart-
13 ment of Education shall not enter into any form of agree-
14 ment with another Federal agency to exercise any author-
15 ity, carry out any function, or provide any service author-
16 ized under the amendments made by this Act.

17 (c) PROHIBITION ON AGREEMENTS AND TRANSFER
18 OF FUNDS.—Notwithstanding any other provision of law,
19 the Secretary of Education shall not make, enter into, or

1 perform an agreement with any other Federal agency to
2 exercise the authorities, carry out the functions, or provide
3 the services authorized in the amendments made by this
4 Act.

5 (d) INTERAGENCY AGREEMENTS SHALL HAVE NO
6 FORCE OR EFFECT.—

7 (1) IN GENERAL.—The Interagency agreements
8 listed in paragraph (2), any addenda to any such
9 agreements, or any similar successor agreements,
10 shall have no force or effect with respect to the
11 amendments made by this Act.

12 (2) INTERAGENCY AGREEMENTS.—The Inter-
13 agency agreements listed in this paragraph are the
14 agreements entered into by the Department of Edu-
15 cation and—

16 (A) the Department of Labor relating to
17 the administration of Department of Education
18 programs, on May 21, 2025;

19 (B) the Department of Labor, relating to
20 the Office of Elementary and Secondary Edu-
21 cation, on September 30, 2025;

22 (C) the Department of Interior, relating to
23 the Office of Indian Education, on September
24 30, 2025;

1 (D) the Department of Labor, relating to
2 Higher Education Programs, on September 30,
3 2025;

4 (E) the Department of Health and Human
5 Services, Administration for Children and Fam-
6 ilies, relating to the CCAMPIS Program, on
7 September 30, 2025;

8 (F) the Department of Health and Human
9 Services, relating to the National Committee on
10 Foreign Medical Education and Accreditation,
11 on September 30, 2025; and

12 (G) the Department of State, relating to
13 International and Foreign Language Education,
14 on September 30, 2025.
