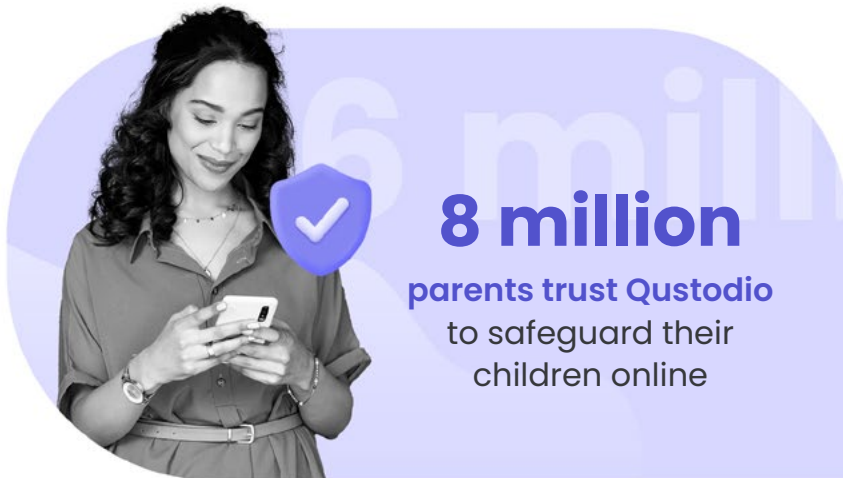

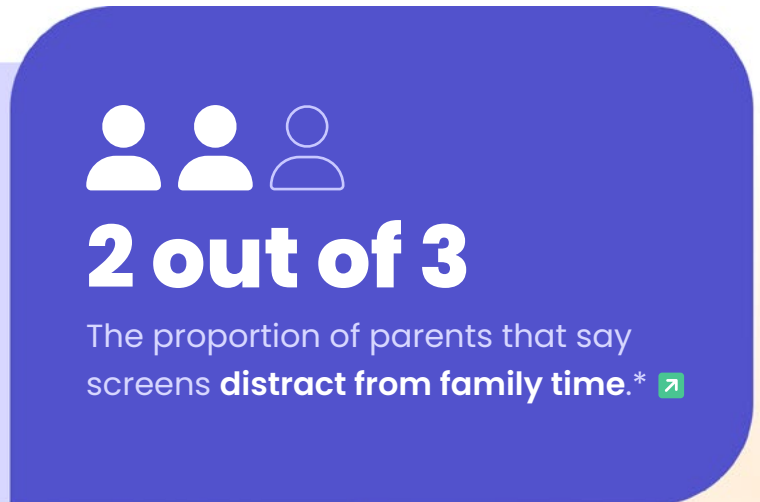
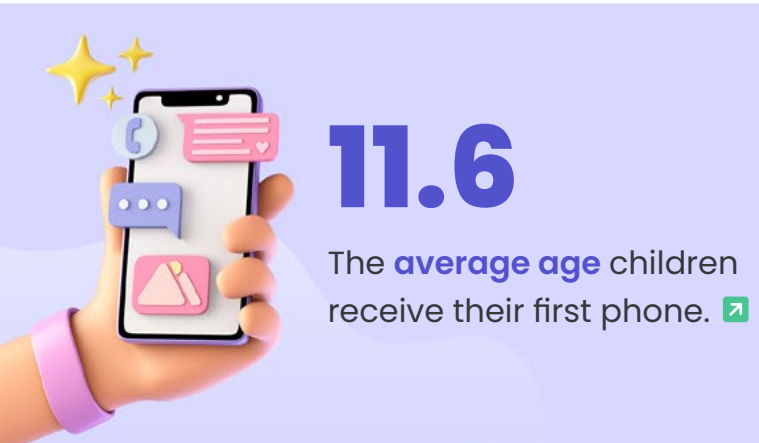

## 2010

Following the release of the iPhone 4, friends and colleagues **Eduardo Cruz**, **Josh Gabel**, and **Josep Gaspar** see the opportunities – and risks – of the influx of devices about to enter families' homes.



## 2011

They **create a prototype**, based on intuitive visual data, to help families keep their kids safe online.



## 2012

The trio found **Qustodio** (a name that refers to the Latin term for guardian, "custodia"). The initial product allows families to monitor their children's activity on Windows computers.

## 2013

Qustodio's platform expands to support more digital devices with **Mac, Android, and iOS integration**.



## 2014

The company signs its first major partnerships with **Telefonica** and **Qualcomm**.



## 2017

Qustodio partners with **Softbank**, a platform of 1 million users, to jointly propose parental control solutions for telecommunications operators around the world.





# 2020

Qustodio publishes its first annual data report on children's digital habits, "Connected more than ever", highlighting trends and insights on kids' app use across the U.S., the U.K., and Spain, between 2019 and 2020. The platform reaches 3 million users.

# 2021

As millions of children around the world are affected by the COVID-19 pandemic, **Qustodio for Chromebook** is launched, offering greater security as they study from home. The same year, Qustodio's second annual data report, entitled "Screen time all the time", reveals skyrocketing levels of tech use.

# 2022

Families in France can now access Qustodio's digital wellbeing suite through new partner, Bouygues Telecom. Qustodio becomes a member of the Family Zone group, offering leading cybersecurity solutions for schools and families. Users hit the 5 million mark.



# 2023

Family Zone becomes Qoria. Qustodio welcomes its 6 millionth user.



# 2024

"Born connected: The rise of the AI generation", Qustodio's fifth annual data report, is released chronicling children's digital habits over the past year - including for the first time, their use of AI tools.
