Discussion Items

Executive Director, Adam Clark, updated the board on the status of the student address verification process. Families are able to report any address changes by contacting the attendance officer at any time, or by submitting a change within the Evolve Parent Portal. Doing either, will then require that new proof of residency documentation be submitted to verify the address. In the last month twenty two changes had been submitted.

Mr. Clark also addressed the board regarding the school's status as a Dropout Prevention & Recovery program. The pandemic has led to an increasing number of younger students enrolling at TRECA, specifically in grades K-6. This increase has changed the proportion of students that are enrolled at TRECA and thus may jeopardize the school's Dropout Prevention status. To receive the designation, schools must have serve a majority of students age 16-21. Currently,

this population is just over 48% of the school's overall enrollment. Mr. Clark explained that he believes the shift in student population will be temporary, as many of the younger students will likely return to their district of residence when the pandemic subsides. However, the shift may lead to the school losing its Dropout Prevention status for the 2020-2021 school year.

Sponsor Report & Feedback

Sponsor Representative, Chuck Speelman, spoke about various legislative measures currently being debated in the state assembly. This includes potential extension of provisions put in place for the 2019-2020 school year. The potential for school report cards to be modified in the coming year, as the state continues to consider how state-mandated testing is to be completed during the pandemic. Mr. Speelman expressed hope that more clarity on the many issues surrounding the pandemic, will be addressed within the next month. Finally, he shared that the annual sponsor report will be completed within the next couple weeks. This report summarizes the evaluation of the sponsor on several items related to the school's performance. Areas include, academic, compliance, fiscal and governance. This report will be provided to the school, and will also be sent out to the families of all TRECA students.
