TRECA provides families the opportunity to submit this electronically via the Evolve Parent Portal or within their annual student paperwork.

## **Discussion**

Sponsor representative, Chuck Speelman, addressed the board to share that Tri-Rivers will be completing a site visit of TRECA by the end of January. In addition, a second visit will take place in the spring. These visits ensure that TRECA is maintaining compliance with Ohio mandates, as well as, the educational plan set forth in the sponsor agreement. Mr. Speelman also shared that Tri-Rivers has officially received its sponsorship extension from the Ohio Department of Education. This means it can now begin working on a potential sponsorship extension with TRECA. This would extend sponsorship beyond the current agreement, ending in June 2023.
