



**School Parent and Family Engagement Policy

Jointly Developed

Each school year, TRECA Digital Academy involves families with our Family Engagement Programs through the use of surveys to collect feedback and ideas related to the development and support of our School Parent and Family Engagement Policy. Every year during our beginning of year events and/or activities, families are surveyed and asked to reflect on the previous year, as well as share ideas for the upcoming year. During the year, TRECA hosts an annual Title I meeting to review federal programs with families, before which the School Parent and Family Engagement Policy is shared for their review. At the end of the school year, families are surveyed as part of our returning-calendar selection tool to collect beginning and end-of-year data. Additionally, after our Family Engagement Events, parents can reflect on the activities and share their feedback.

Annual Title I Meeting

TRECA Digital Academy holds a Title I meeting annually. Events are recorded and shared with parents and families whenever possible. Documents related to school and parent programs are available in multiple languages on our school website and translation services and tools are available.

Families and students are kept informed about Title I Programs via our Learning Management System, school website, social media posts, and via our school newsletter which is mailed to their homes at least twice per year. Each school year, TRECA Digital Academy involves families with our Family Engagement Programs through the use of surveys to collect feedback and ideas related to the development and support of our School Parent and Family Engagement Policy, which includes planning for our Family Engagement Events each school year. This information is also reviewed at our Annual Title I Meetings where families are informed about the budget and asked to provide input into planning.

Families at TRECA Digital Academy have access to live support through SAFE staff members, the Help Desk, teachers, Advisors for students in grades 7-12, and administrative staff members. We offer virtual support via Brightspace and Google Meet (our online meeting tool), as well as face-to-face opportunities at our regional offices. Every staff member has a phone extension that is publicized on our website and included in their email signature and classroom communications. When needed, teachers and support staff make referrals for assistance for students and families to our SAFE Learning Support Specialists. SAFE staff will then assess the situation and determine if referrals to external agencies are warranted. All staff are aware that if there is suspected abuse or if there are concerns for a student's safety, that an immediate referral to the appropriate agency is warranted. SAFE staff regularly interact with probation officers, court systems, counselors, and community partners in an effort to support the whole child. Additionally, social-emotional learning resources are provided to all students in grades K-12. Families can utilize Care Solace to find mental healthcare providers and substance abuse treatment centers.

Building Capacity of Parents

TRECA Digital Academy will build the parents' capacity for strong parent and family engagement to ensure effective involvement of parents and to support a partnership among the school and the community to improve student academic achievement through the following:

TRECA Digital Academy has many avenues available to families who need support as they work to improve the academic achievement and learning engagement of their children. Families can receive assistance, further training, and support at any of our regional office locations. Families can also work with Advisors and SAFE (Student and Family Engagement) staff members, in addition to classroom teachers, to be able to support their children's learning and engagement with TRECA. Parent-teacher conferences are offered twice per year at the time of progress reports, but families may request a conference at any time. Information about curriculum, Title programs, and assessments are available on our school website. We also have community partners available to parents through our ongoing meetings and events. Through our Family Engagement Events, we can introduce families to community partners, such as OCECD, who have been present at back to school events in previous years.

We have also offered monthly parent/learning partner sessions throughout the school year that have covered various topics. Topics are chosen from parent feedback that we have received. Some of the topics that have been highlighted so far include: Checking & Understanding Student Progress, College Planning/Scholarships/Financial Aid, Test Taking Tips, Positive Behavioral Interventions and Supports (PBIS), Social-Emotional Learning (SEL), How to Keep Kids Active When Learning at Home, Health and Well-Being, How To Be a Good Learning Partner, Mental Health, and Internet Safety. Families can join the sessions live or watch the recording at their convenience.

Building Capacity of School Staff

TRECA Digital Academy will provide training to educate teachers, specialized instructional support personnel, principals and other school leaders, and other staff, with the assistance of parents, in the value and utility of contributions of parents and in how to reach out to, communicate with and work with parents as equal partners, implement and coordinate parent programs, and build ties between parents and the school by:

Staff members receive regular training at staff meetings, where we continue to work on skills related to building relationships and removing barriers to learning. All staff members were invited to participate in training from WhyTry?, which is a resilience-building program that we began incorporating into activities during the 2018-19 school year. Additional WhyTry? training opportunities have been offered in subsequent years. Additionally, all Advisors and instructional

staff were trained in the Check & Connect Mentoring Program through the University of Minnesota in order to build relationships with students that would support student engagement and academic growth.

An Action Team for Partnerships Committee was formed in the 2021-2022 school year. The group consists of a team of administrators, teachers, staff members, parents, and the Family Engagement Specialist to represent applicable stakeholder groups. The committee surveys parents and families for their feedback and input regarding family engagement activities. The ATP was established under the belief that family involvement is critical for student success and achievement. This group is modeled after the Six Types of Family Involvement, which is a research-based framework created by Dr. Joyce Epstein. Each year, the ATP will create a goal-oriented action plan and brainstorm ways to enhance our family engagement practices in each of the following areas: Parenting, Communicating, Volunteering, Learning at Home, Decision Making, and Collaborating with the Community.
