Continental U.S. Freight Allowance: Freight terms are FOB and will be prepaid and allowed by ASC Engineered Solutions according to the following total order values per product category (excludes Hawaii and Alaska). All exclusions will be shipped Ex-Works point of shipment.

Minimum order amount is \$250. All orders must be in full box quantity or bundle quantity.

Minimum order for any international order is \$500; all Ex-Works unless other terms are in writing.

Canadian orders will be handled through our Canadian division and terms will be set by that division.
