Attention Anvil International and Smith-Cooper International Customers:

In May 2019, we completed the merger between Anvil International and Smith-Cooper International. Since completing the merger we have been hard at work integrating the businesses to bring you the level of quality and service you have come to expect from both companies. On November 2, 2020, we will take a significant step forward by integrating the businesses on the Anvil International ERP system, allowing customers to place one order for all Anvil and Smith-Cooper International products. To ensure a smooth transition while maintaining the highest level of customer service, we have outlined several activities that will be taking place during this transition.

- October 30th: All legacy Smith-Cooper International distribution centers will be closed. This includes our locations in Commerce, CA, Vancouver, WA, Elk Grove Village, IL, and Lawrenceville, GA. During this shut down the Smith-Cooper International Inside Sales team will be available to assist customers and will have the ability to process orders and quotes, but shipments and will call pickups will be postponed until Monday, November 2nd. All legacy Anvil locations will remain open for shipment and will call during the transition.
- November 2nd: All facilities will reopen, and shipments and will call pickups will resume at all legacy Smith-Cooper International locations. This will be the first day customers can submit consolidated purchased orders for Anvil and Smith-Cooper International products.

EDI & VMI Partners:

Effective at the end of business on October 29th, EDI services between Smith-Cooper International and our trading partners will be suspended while we transition to our new ERP system. All orders placed with Smith-Cooper International on Friday, October 30th must be submitted by email, phone, or fax. Effective November 2nd customers will have the ability to utilize EDI & VMI to place consolidated orders for both Anvil and Smith-Cooper International products, via Anvil's established EDI & VMI platforms.

Smith-Cooper OrderPro Users:

Effective at the end of business on October 29th, Smith-Cooper International customers will no longer have access to OrderPro to check inventory and pricing, or to place orders. All orders placed with Smith-Cooper International on Friday, October 30th must be submitted by email, phone, or fax. Effective on Monday, November 2nd customers will be able to view Anvil and Smith-Cooper International inventory online utilizing the sales portal located on the Anvil International website. Return Material Authorization (RMA):

Effective November 2, 2020, Anvil and Smith-Cooper International will be moving to a consolidated RMA policy and process.
