a. FYI: City of Virginia Beach FY24-25 Focused Action Plan

Beth Hundley, Deputy Director reported that Assistant City Manager Monica Croskey Chaparro was the lead for this report that translates the city's vision and goals into three key focus areas: Govern, Envision and Invigorate.

The initiative associated with the Arts and Humanities Commission is under the **GOVERN** Category:

• 1.4- Complete a comprehensive review of the City's Community Organization Grant (COG), Regional Grant and Arts & Humanities grant processes

Cultural Affairs would be held accountable for the following initiatives under the **INVIGORATE** Category:

- **3.10** Conduct a community engagement effort to develop district identities for the 10 new Council districts
- **3.11** Explore and implement opportunities to partner with the community and small businesses to activate creative placemaking and cultivate a sense of identity to strengthen the civic, cultural, and economic environments for areas throughout the city
- **3.12** Conduct capacity mapping to identify potential areas for community-based revitalization projects and placemaking effort
- **3.13** Enhance the reach and distribution of arts throughout the city
- **3.14** Explore dedicated funding opportunities that comparable municipalities use to support culture and art

Dr. Cynthia Romero, Chair thanked the Assistant City Manager for her work putting the plan together.

b. FYI: City of Virginia Beach Comprehensive Plan 2040

This report is updated every five (5) years and shares what direction the City is going on the subject matter of development and transportation. e. Public Art Committee

Mia Guile provided the following Public Art Committee update:

Mt Trashmore Mural

- "Helping Hands" mural by local artist Aimee Bruce
- Installed in 2018, planned 2-year lifespan.
- Parks & Recreation have decided to begin construction on the long-awaited new staircase.
- Staircase to be removed mid-November, with new stairs beginning construction early December.
- Artist has been notified and is supportive.
- Parks and Recreation has no plans at the moment for artwork on the new staircase.

Historic Kempsville Public Art RFQ

- 62 applicants total, tremendous response.
- Selection committee members include:

Woodstock Skate Park Sculpture

- Public Works is currently working with Parks & Recreation to complete electrical requirements.
- Once electrical work concludes, we should have a better timeline for installation, etc.
- Planning for an unveiling in early 2024 with the new councilmember for District 1.

Maintenance Updates

- Delight has been restored (patina corrected, cleaned and waxed)
 - Located at the Oceanfront 33rd & Atlantic
 - ° Artist Mike Cunningham
 - Four bronze dolphins jumping through a hoop over the waves.
- 3 other bronze sculptures have been cleaned and waxed.
 - The Kiss by Gary Alsum in Town Center
 - Children Playing by Robert Cunningham at the court complex
 - ° Friendship Anchor (artist unknown) at Kempes Landing Park

Plans for continued maintenance of current collection, ongoing.

Potential Public Art Locations & Projects

- The committee discussed a variety of community locations for potential public art.
 - ° City parks, highway over/underpasses, city construction sites, areas with high pedestrian traffic, public utility sites
- The committee also brainstormed ideas for upcoming projects.
 - ° Focused on a goal of choosing one large project with multiple medium to small projects.

Mia Guiles promoted the interactive public art district GSI mapping for the Commission to try out.

- <u>Sue Grube-</u> Enjoyed the productions of Little Theatre of Virginia Beach; Ballet Virginia at Zeiders; Fiddler on the Roof by Virginia Stage Company and shared a gifted program that the Sandler Center Foundation in collaboration with Ballet Virginia and the Virginia Beach City Schools. There are three elementary schools that have after school programs called the "Excellence" program and have the option to participate in ballet.120 students are participating in four schools.
- <u>Sunny Peoples:</u> Shared an upcoming event called Wakanda Giving by TACA/ Rita Cohen
 in collaboration with Norfolk State and Hampton University, Williams and Mary and VCU

- on Nov 18 at 6 pm at ODU that will include a dinner, fashion show and performances. Lastly, Access Virginia was on the campus of Norfolk Campus Tidewater Community College for Disability Awareness.
