Virginia Beach Fire Prevention Flaming Effects Disclosure Statement

Listed below are the minimums requirements for the setup and use of flame effect before an audience.

- All parties involved in the setup and operation of flaming effects before an audience shall have read NFPA 160 (Standard for the Use of Flame Effects Before an Audience) and understand all codes and standards as they pertains to their equipment and the operation thereof.
- The use of a flame effect within the City of Virginia Beach requires that the operator of the flame effect apply for a use permit through the City of Fire Prevention Bureau. The operator shall also contact the Special Events and Film Office to fill out other required applications.
- Permits shall be applied for no less than 30 days out from event date.
- All operators must be a minimum of 21 years of age.
- Flame affects plan in accordance with NFPA 160 must be submitted with the application, and be approved by the VBFMO before any permit is issued.
- > All flaming effects shall have a description of the design and performance specifications submitted with the permit application.
- ➤ All flaming effects shall have written operating instructions, including start-up, show operations, normal shutdown procedures, and emergency shutdown procedures. These documents shall be available onsite for review by the VBFP at all times.
- When required, a walk-through and representative demonstration of the flame effects shall be provided to the VBFP before the flame effect is approved.
- > The operator of any flame effect shall understand and be familiar with the operating manual or instructions.
- The flame effect operator shall be responsible for storage, setup, operations, and teardown of all flame effect materials, devices, equipment, systems, and supervision of assistants.
- > No person shall use or handle flame effect materials or devices while under the influence of the following.
 - Intoxicating beverage
 - Narcotics or controlled substance
 - Prescription drugs and/or nonprescription drugs that impair judgment

At any time that the codes and standards in NFPA 160 are not followed creating a safety hazard the VBFP has the authority to revoke the operators flame effect permit.

Virginia Beach Fire Prevention Flaming Effects Application

Application for Permit to Operation Flame Effects within The City of Virginia Beach Before a Proximate Audience

Instructions

All information must be printed in ink or typewritten.

Submit two (2) copies of this application and all its attachments to the VBFP. The VBFP must be in receipt of this application not less than 30 days prior to the event. A post mark or its equivalent is not the determining factor for having submitted an application in a timely manner.

- Line 1. Provide name of person or company applying for a flame effects permit.
- **Line 2**. List telephone number where applicant may be reached.
- **Line 3 & 3b.** Use mailing address the applicant can expect the quickest delivery service. If available, provide email address and/or fax number.
- **Line 4.** What is the physical address (location) of the permit applicant if it's different from the mailing address given?
- Line 5. List city, state and zip code for the complete mailing address.
- **Line 6.** Print the name of the person who is representing the applicant listed on Line 1 and whose signature appears on Line 16.
- **Line 7.** The use of flame effects before an audience is governed by provisions contained in the Virginia Statewide Fire Prevention Code (VSFPC) and its incorporated NFPA 160 standard. **This application is for a permit to use flame effects on a temporary basis.** For flame effects that are to be used for a period greater than 180 days, the applicant should consult with VBFP for further direction or information on <u>permanent</u> flame effects.
- ▶ If in tandem with **Fireworks** A permit to use flame effects does not confer approval to use fireworks or pyrotechnics. To use fireworks or pyrotechnics in tandem with flame effects, a separate application is to be completed and submitted with this application as a package. If fireworks are to be used, check the box located in the "note" below Line 7.4.
- ► Check each circumstance flame effects will be used and whether it will be inside or outside a building or both.
- **Line 8.1 through 8.3.** Print the name and address of the venue at which flame effects will be used along with the name and telephone number of the venue manager.
- **Line 9.** Provide the date and time frame the use of flame effects will occur.

Line 9.1. The box is to be checked if the use of flame effects will occur on multiple, consecutive dates. Checking the box for Line 9.1 is intended to apply *only* to those multi-day displays that are identical in location, types and numbers of devices. If the dates are not consecutive, if the number and/or types of flame effects are not identical to the day before, or if identical device setups will occur at different locations or dates, a new permit is required.

If multiple dates are planned for identical setups, list the additional dates and times on a separate sheet. Label or indicate at the top of the sheet that it's an attachment for line #9.1.

Line 10 The VSFPC provides an opportunity for the operator to prove to the fire official, sponsor and venue manager that the flame effects and devices will operate as planned and within the safety parameters required by the VSFPC. Designate a date and time at which a walk-through can begin and a representative demonstration will be available.

Line 11. Check the classification of the flame effects system as they are described in NFPA 160.

Lines 12.1 and 12.2. Provide the name and age of the operator who will be in responsible charge of the flame effects along with the name and age of any assistants.

Line 12.3 List the number and types of flame effects

Line 13 through 13.6. A plan for the use of flame effects is to be submitted to the VBFP as part of the permit application. The plan is also to be readily accessible at the venue where flame effects will be used and is subject to inspection.

The specifics of the plan are to be in conformance with the NFPA 160 standard. Once accepted, approved and a permit is issued, all subsequent additions or modifications are to be preapproved before using any modified flame effects. The plan should account for each appropriate item for the circumstance the effect will be used.

<u>Line 13.1</u> contains items that should be addressed in the plan and are common between indoor and outdoor flame effects.

<u>Line 13.2</u> contains items that should be addressed and are specific to the outdoors.

<u>Line 13.3</u> contains items that should be addressed and are specific to the indoors.

<u>Line 13.4</u> lists items the plan should address as they relate to the operator's knowledge, skills and abilities. It should also address the level of control the operator or performer have on the flame effects.

Line 13.5 lists items that deal with unattended effects.

<u>Line 13.6</u> deals with the certification of costumes, set, scenery, and rigging materials being inherently flame - retardant or have been treated to achieve flame retardancy when exposed to flame effects when such items are exposed to or are in the area affected by a flame effect device.

Line 14. Attestation that is largely self-explanatory but should be read carefully. If flame effects are used in tandem with fireworks or pyrotechnic devices, the flame effects permit becomes secondary to the fireworks permit for the purpose of determining the correct permit fee.

Lines 15. Signature line for the person listed on Line 6.

Submitting an incomplete or late application is cause for the application to be returned to the applicant without further processing

Submit one (1) copy of this application complete with all attachments to the VBFP. The VBFP must be in receipt of the complete application at the address listed below <u>not less than 30 days prior</u> to the event. A post mark or its equivalent is not the determining factor for having submitted an application in a timely manner.

If an application is received with incomplete information, the application may be returned without further processing resulting in the potential delay or denial of the application.

After initial review, a completed and satisfactory site inspection at the location/date indicated on lines 9 and/or 10, the VBFP representative in attendance will issue the permit.

14. By my signature below, I attest the information provided is complete and accurate. I acknowledge and agree to comply with all applicable requirements of the Virginia Statewide Fire Prevention Code (VSFPC) and the referenced NFPA 160 standard governing the use of flame effects before an audience even those not specifically covered or expressed on this application.

I also acknowledge that if a permit is issued it shall be valid only at the location listed on the application and for the specific date(s) and time(s) for which it is issued and will expire at 12:01 AM on the date(s) provided on Lines 9 and/or 9.1 whichever is later. (5.1.3.2)

If approved to proceed, I acknowledge that such approval is conditional upon continued compliance with the VSFPC. I further acknowledge and understand that any VSFPC violations identified after the permit has been issued may result in immediate suspension or revocation of a permit.

Flaming Effect Classifications

Group I

An attended, manually controlled flame effect.

Group II

An individual or group flame effect designed for unattended operation that is temporarily, or permanently installed outside any structure.

Group III

An attended, temporarily installed flame effect for a specific production with limited operation and fixed time for removal.

Group IV

A large individual or group flame effect that is temporarily or permanently installed inside or outside any structure designed for unattended operation without a main show supervisory control system.

Group V

A large individual or group flame effect that is temporarily or permanently installed inside or outside any structure and is designed for intermittent or continuous operation under the supervision of a main show control system but without full-time supervision by a technician.

Group VI

A large individual or group flame effect that is temporary or permanently installed inside or outside any structure and is designed for intermittent operation under the supervision of a main show control system and a technical director, with cast members in close proximity to the effect at time of operation.

Group VII

An individual flame effect that can be temporarily or permanently installed inside or outside any structure that, due to its unique operating requirements, does not fit into any other classification.
