

# City of Virginia Beach Personnel Board 2024-2025 Annual Report to City Council

Chair: Edward Jones, Chair, in Collaboration with All Personnel Board Members

### **Executive Summary**

The Personnel Board and staff liaisons compiled the 2024-2025 Annual Report to City Council covering the period of July 1, 2024 - June 30, 2025. The Personnel Board meets on an as-needed basis to hear appeals of grievances and discipline of City employees. The Personnel Board exists in accordance with the two State Code Sections that provide for the establishment of a Personnel Board and a Grievance Procedure. The decisions reached by the Personnel Board as stated in §2.1-114.5:1(d) are final and binding.

In fiscal year 2025, the Personnel Board conducted nine grievance hearings during the period of July 1, 2024 - June 30, 2025. During these hearings, the Board upheld eight of the recommended decisions from the various departments. There was only one Personnel Board decision that resulted in an overturned decision. This indicates that City management handled workplace issues that were grieved in accordance with policy and procedure.

The Personnel Board provided 377 volunteer service hours for the City of Virginia Beach. During the fiscal year, hearing packets were reviewed for three additional hearings that were settled prior to the Personnel Board taking place, and three public meetings were held.

### **Mission Statement**

The mission of the Personnel Board shall be to hear and decide employee grievances as defined in Section 2-129 (a) of the City code. The Personnel Board serves the City Council on matters pertaining to personnel administration and is a quasi-judicial review body for hearing employee appeals of certain disciplinary actions. In conducting its business, the Board considers the rights and interests of City employees, the City administration, and the citizens and taxpayers of Virginia Beach.

### **Accomplishment of Goals and Objectives**

The Board committed time and talents to timely hearings, so workplace grievances were addressed appropriately. In addition, the Board has been supportive of the following initiatives from Human Resources to support the workforce in addressing grievances:

- 1. Human Resources provided resources and online documentation to assist employees and managers in developing effective techniques to present testimony and evidence and prepare witnesses for the Personnel Board hearing.
- 2. A comprehensive review of the Personnel Board Rules and Regulations was completed, resulting in enhancements and clarifications designed to improve the clarity and accuracy of the Board's processes. These updates ensure greater alignment with applicable Virginia and City codes, as well as the City's established policies and procedures. The revised Personnel Board Rules and Regulations became effective on April 24, 2025.

### Membership and Attendance

The City of Virginia Beach's Personnel Board consists of five regular members, with one being a member of the merit service (MS). Additionally, there may be up to four alternates, with two of them being a part of the MS, below the level of division manager. The members are appointed by the City Council for a term of three years. Alternate members only serve when regular members are not available.
