Executive Summary

On April 19, 2022, the Virginia Beach City Council approved a Resolution to reconstitute the Virginia Beach Community Criminal Justice Board (CCJB) based on changes in state law requirements and, accordingly, appointed new board members. The CCJB meetings were held quarterly and during the first fiscal year covering the period of July 1, 2022 – June 30, 2023, the newly appointed volunteers and liaisons:

- Met as a newly formed body to review and vote on governance, bylaws, board scheduling, and a mission statement.
- Received operational briefings on the operation of local community-based probation and pretrial services.
- Received educational presentations regarding local criminal justice services with a focus on roles related to strategies to enhance integration and to divert individuals from regional or local jails.
- Began to evaluate and monitor community programs, local community-based probation and pretrial services, and facilities to determine impact on defendants and offenders.
- Reviewed the submission of all Department of Justice criminal justice grants regardless of the source of funding.

The most significant accomplishments are detailed below for your consideration.

Mission Statement

The mission of the Virginia Beach Community Criminal Justice Board is to fulfill the requirements of Virginia Code § 9.1-180 to the best of our ability and to make the criminal justice system as effective as possible for the citizens of Virginia Beach.

Accomplishment of Goals and Objectives

Over the past fiscal year, the CCJB, though its appointed board members and its liaisons, worked on the following key matters in furtherance of its mission:

- 1. The Virginia Beach CCJB met for the first time in July 2022 and reviewed the regulatory requirements as set forth in Virginia Code § 9.1-180, the Comprehensive Community Corrections Act of Local Responsible Offenders ("CCCA"), the Pretrial Services Act, and the CCCA Local Community Based Probation Minimum Standards as defined by the Virginia Department of Criminal Justice Services.
- 2. The CCJB established By-laws, a Mission Statement, a schedule of recurring meetings and a policy related to remote participation.
- 3. The Deputy City Attorney provided training for board members as follows:
 - a. Roles of board officers and members
 - b. Virginia Freedom of Information Act
 - c. State and Local Government Conflict of Interest Act
 - d. Virtual Meeting regulations
- 4. Received educational briefings on the following topics:
 - a. Community Corrections and Pretrial Program
 - b. The Office and duties of the Virginia Beach Commonwealth Attorney
 - c. Responsibilities of the Office of the Public Defender
- 5. Discussed unmet community needs and strategies to enhance processes and services that will divert individuals from the criminal justice system.
- 6. Reviewed proposals for the Byrne JAG Grant as allocated to the City of Virginia Beach in the amount of \$71,760.00.

- Evaluate and monitor the Community Corrections and Pretrial operations and DCJS grant to ensure compliance and community impact.
- Leverage key stakeholders to facilitate local engagement and collaboration to pursue system process improvements.

Recommendations to City Council

- Continue to promote collaborative partnerships among local criminal justice officials by providing a forum to discuss existing system outcomes and enhancements.
- As our environmental challenges evolve, continue to support a robust array of services with the goal of preventing criminal justice system involvement and reduce recidivism.

Additional Information

The Virginia Beach CCJB currently has eleven (11) board members and two (2) staff members. The board meets once each quarter to review grant proposals and evaluate relevant information about community services and trends. The board is working towards providing a framework to engage in a comprehensive planning process that will fully utilize the CCJB as specified in §9.1-180 of the Code of Virginia.
