funding for pedestrian scale lighting the entire distance, medians and intersections to allow users to cross Norfolk Ave to the trail safely. Also, upgrading of signals and crossings at Birdneck and Pacific will allow transitions to the surrounding community at the trail ends. This trail was originally acquired with Open Space funding and has been a huge success. Discussions continue with Dominion Energy regarding a multi-use/bike path along the proposed above ground line, which starts near Castleton neighborhood and turns due west towards the ITA.

- Discussions regarding the design phase of Innovation Park Phase II for property along Princess Anne Road from Hudome Way to the entrance of VB National
- Both above topics have potential for future open space options to attached parcels
- Fall Site Tours are being planned with at least one along Shore Drive. Members of OSAC are welcomed to attend. Dates/times will be sent once determined.
- ATAC annual report referenced its partnership with OSAC.
