2. APPROVAL OF MINUTES: July 22, 2024

A motion made by Francis Drumm and seconded by Jarrod Katzer to approve the July 22, 2024, minutes, passed unanimously.

3. NEW BUSINESS

- a. November/December meeting The committee members in attendance agreed to cancel the November meeting and meet the first Monday in December, which is December 2nd.
- b. CVOW Trail Presentation Chad Morris

In reference to questions raised during the previous meeting about the City's portion of the right of way for the Coastal Virginia Offshore Wind (CVOW) transmission line corridor and its impact, Mr. Morris, Planning, Design & Development Administrator, reviewed the path of the CVOW Trail Concept Plan. He focused on several high traffic areas and provided photos of existing CVOW easements. A copy of the presentation is attached.

4. OLD BUSINESS

- a. Vacancy Chair Bernick recently reviewed the applications for a potential member to fill the existing member vacancy and provided a recommendation to Council.
- b. ITA Plan update Staff are in the final stages of creating the master plan and currently working on cost estimates. Mr. Morris expects to meet with the City Manager in early September and then present to City Council by October 15th.
- c. Annual Report Chair Bernick asked for comments on the Annual Report sent by email on Friday, August 23rd. Since there weren't any changes suggested, Chair Bernick will submit the final report before the August 31st deadline to the City Clerk's Office.
- d. Letter for Va Outdoors Plan Update After discussion, the committee decided a letter is not necessary.
- e. Funding recommendations for undeveloped/underdeveloped properties The workgroup met by Zoom last week and divided the options into two categories, Plans A & B, which are listed below.
 - i. Plan A recommend pursuing bonding for \$30M to develop the top 3 of the undeveloped and underdeveloped properties previously discussed.
 - ii. Plan B do not recommend bonding.

After several questions and discussion to clarify the bonding process, Vice Chair Katzer made a motion to recommend Plan A, seconded by William Fleming and approved by those present.

f. Virginia Land Conservation Foundation (VLCF) Grant application

Ms. Green is almost finished preparing a grant application for a potential acquisition, with an application deadline of August 28th. She requested a letter of support from OSAC. Chair Bernick provided a draft for review. Once agreed, he will send the form letter to several other organizations for their support.

- f. LRNOW Vincent Bowhers
 - Beach Garden Park Cleanup was August 10th.
 - 514 lbs., 117 volunteer hours, and debris removed included abandoned clothing, a tent, and a bike.

- Water was too shallow to launch boats.
- December July: 50 cleanups, 1,979 volunteer hours, and 11,077 lbs. of debris removed.
- Next Cleanup (International Coastal Cleanup) Scarborough Square (West Neck Creek) will be on September 8th.

g. Active Transportation Advisory Committee - Maury Hill

- Chad Morris reviewed the ITA plan. Activities concentrated in the north with trails and boardwalks in the south. The current tree canopy is at 91% and plans are to add 25 acres, with additional mitigations. One recommendation includes a shared park for potential cross-country venue and baseball complex.
- Council members have approached ATAC Chair Camp in search of parking areas along the future VB Trail. P&R Director Kirschman indicated that despite best efforts, parking along the Cross Charlotte Trail remains an issue due to the trail's overwhelming popularity.
- Clean Community Commission Zero Waste Awareness Week is the first week in September, and Mr. Hill will be presenting to Council, focusing on improvements everyone can do. Also included will be tips on recycling correctly, increased public education, and avoiding single use plastics.

h. Workgroups

- Handbook workgroup Vice Chair Katzer distributed and reviewed a draft outline of the member guidebook.
- ITA workgroup Scheduled to meet Wednesday and will review recommendations.

6. CITIZEN COMMENTS

Mr. David Gressens, representing Baseball 757, has an interest in the ITA Plan, specifically in the design of the potential baseball fields.
