3. NEW BUSINESS

a. VLCF Grant Announcement – Ms. Green announced on November 27th, 2024, Virginia Beach was awarded \$650K for the Hancock North Landing Open Space Land Conservation Grant application submitted in August. Virginia Beach also received \$100K for the Pleasure House Point Access/Waterfront Area application. Overall, Governor Glenn Youngkin awarded \$14.4M in Land Conservation Grants protecting 11,220 acres through the Virginia Land Conservation Foundation. Chair Bernick and members present expressed their appreciation for Ms. Green's diligence in writing and submitting a successful application.

He asked members to review and provide comments by the end of the year so all comments could be incorporated, and a final product be presented at the January meeting.
