2. APPROVAL OF MINUTES: DECEMBER 4, 2023, MEETING

A motion made by Francis Drumm and seconded by Vincent Bowhers to approve the Minutes from the December 4th meeting was passed unanimously. Chair Bernick welcomed the newest member, Kathleen Paige Simmons.

3. NEW BUSINESS

a. Virginia Beach Trail Update - Steve Lambert & Walter Camp

Mr. Steve Lambert, Planner III, and Mr. Walter Camp, ATAC Chair, provided status updates for four separate phases of the planned Virginia Beach Trail, and showed the link with other Hampton Roads Regional Trails. In December, the City was awarded a \$14.9M USDOT Safe Streets and Roads for All grant for Phase 1 of the Virginia Beach Trail, from Newtown Transit Station to Town Center. The City had filed four prior grant applications for federal funding since 2019. On Tuesday, January 2nd, City Council voted unanimously to accept the grant, commit the required matching local funds, and appropriate the funding into the VB Trail CIP. The total is \$19.5M, including the \$14.9M SS4A grant, \$2.9M in local funds, \$902K from the sale of easements for Dominion's CVOW transmission lines, \$750K in a HUD grant announced in December 2022. Simultaneously, Dominion Energy's plans to replace its transmission infrastructure in the same corridor will need to be coordinated. Design and engineering is scheduled during 2024 and construction must be completed within five years of the signing of the agreement. Phase 1 will include a pedestrian bridge over Independence Blvd. A PER (preliminary engineering report) is currently underway for Phase 2, which is planned as 2.6 miles of shared-use path from Town Center to S. Plaza Trail. Phase 3 is planned as 5.1 miles of shared-use path from S. Plaza Trail to Birdneck Road. Phase 4, already completed, is 1.7 miles of existing shared-use path from Birdneck Road to Rudee Loop Park and includes the Norfolk Avenue Trail and Pacific Avenue Bridge. Mr. Camp provided a brief history of the trail as it has appeared in several City documents and anticipated future uses are not only recreation but also a necessity as an additional transportation option that increases residents' accessibility to essential destinations.

- b. Historic Kempsville Kayak Launch Update Corinna Green Ms. Green reviewed the location of the kayak launch and advised this is a joint project between Public Works, Public Utilities, and Parks and Recreation. Bids have been received and total construction cost are \$2.5M including \$1.1M of Parks and Recreation funding. Plans include a pump station, kayak launch/floating dock, picnic shelter, and ADA pavers.
- c. February Meeting/Potential Tour Date Chair Bernick advised this meeting room is not available in February but meeting rooms at the Joint Use Library (JUL), Tidewater Community College campus are available. Chair Bernick asked if members were interested touring potential properties discussed for acquisition. Members agreed a tour would be beneficial but agreed not to replace a formal meeting.

4. OLD BUSINESS

- a. Urban Forest Management Plan Status & Open Survey Brooke Costanza Ms. Costanza reviewed the social, economic, and health benefits of trees, and the ecosystem service value to Virginia Beach. Virginia Beach aims to achieve 45% tree canopy coverage by planting, nurturing, and protecting the urban forest. A challenge is ensuring the annual tree loss is not greater than the annual tree gain. Using Light Detection and Ranging (LiDAR), Virginia Beach measures the tree canopy and can track it over time. Education is a key component. Ms. Costanza reviewed the tree inventory and dashboard. Chair Bernick thanked her for her very informative presentation. A copy of the presentation is attached.
- b. Dominion Energy Coastal Virginia Offshore Wind (CVOW) Project Tree Mitigation Ms. Green and Ms. Costanza advised the City received approximately \$1.1M to mitigate the trees impacted by the Coastal Virginia Offshore Wind project. A kick-off meeting included multiple departments and next steps include developing the criteria needed to determine locations. Ms. Costanza asked members to send her any suggested locations. Trees will be planted using a contract and will include a one-year warranty period. Tree clearing by Dominion will initiate in January and must be completed by April 15, 2024.
- c. ITA Open Space Strategies Chair Bernick thanked the subgroup for their efforts preparing the strategies and he anticipates finalizing at the February meeting.
- d. Acquisition Updates

- e. Open Space Acquisition Process & Criteria Chair Bernick and Ms. Green have prepared a draft sequence of steps for acquiring property and are working with the City Attorney's office to finalize. They anticipate providing a draft at the February meeting.

- d. Active Transportation Advisory Committee Maury Hill/ATAC Chair Camp
 - City of Chesapeake project underway related to greenways, blueways, trails, open space, tree canopy, and related matters, <u>Chesapeake Trails and Connectivity Plan | Chesapeake, VA (cityofchesapeake.net)</u>.
