## **Fees & Payment Policy**

Reduced Fee Price: To qualify, participants must have a current Fee Waiver. Fee Waivers require annual renewal. Visit any Virginia Beach Community Recreation Center for more information.

The monthly sessions are due by the dates above and secures your child's space. Fees are calculated by the days we provide service divided into 9 ½ payments. The program closure dates indicated as well as unexpected event days (i.e., Inclement Weather) are prebuilt into the fee structure. Fees are not prorated.

If your session payment is not received by the due date, *your child will be withdrawn and unable to attend.* Should this occur, you cannot pay online. You must call our office to pay the session plus a \$25 reinstatement fee to attend. Should this occur, re-registration is based on space availability.

**Cancellations and Refunds** must be submitted in writing at least 7 days prior to the start date to be eligible for a refund. Administrative and Registration Fees are non-refundable and non-transferrable. Approved refunds will be processed back to the original payer and payment method. Please note session cancellations may result in the need to re-register. Should this occur, re-registration is based on space availability.

- Cash refunds are subject to availability of funds at any recreation center
- · Check refunds can take up to 30 days to be received
- Credit Card refunds should post within 2-3 business days of being processed
