

Parks and Recreation - Lynnhaven Municipal Marina Transient Dockage Agreement

Transient Guidelines

- Contact staff at 757-460-7590 to reserve your dates. Reservations must be made no less than 5 days in advance of arrival. Reservations and payments can be made by phone or in person upon submission of all necessary documentation.
- 2. Transient Dockage Fee: \$30/day for the first three days, then \$15/day each additional day up to 7 days.
- 3. Slips are rented on a first come basis, subject to availability and payment.
- 4. All boats seeking to use transient dockage must be smaller than 36ft. in length.
- 5. Mooring lines are not provided, boaters must supply their own lines.
- 6. All fees and Insurance requirements are due no later than 5 days in advance of arrival.
- 7. Check in on arrival day by calling staff at 757-460-7590.
- **8.** All refund requests must be submitted in writing to marina staff and will be processed within 7–10 business days upon approval.
- **9.** Parking permits are issued to vehicles registered to the vessel owner and their immediate family only. Boater Permits are NON-TRANSFERABLE. Any vehicle NOT displaying a CURRENT permit may be ticketed and/or towed at the Owner's sole risk and expense. The Marina DOES NOT warrant the availability of parking. Overnight parking at the owner's risk.
 - * Check-in & Check-out times are flexible and based on availability and prior authorization from the Marina. *

Guest Responsibilities

- 1. All guests must abide by the Dock Regulations and are responsible for their visitors.
- 2. Marina facilities shall not be used for solicitation, advertising or any other business purposes, either from the vessel or from ashore.
- 3. In the event of inclement weather guests shall take whatever emergency measures are necessary to ensure the safety of their vessel, other yachts, the rental slip and docks in the event of an emergency. The guest shall immediately remove his vessel from the dock upon the issuance of a named storm warning to the local area by NOAA.
- 4. If guests' boat sinks or is disabled while at LM docks, the guest will have the boat repaired, refloated or towed.

Insurance Requirements

A current copy of the Declaration of Insurance Form from boat owner's insurance agent that documents valid marine insurance for boat owner's craft during the term of this permit agreement including protection and indemnity coverage at a minimum limit of three hundred thousand dollars (\$300,000.00). Please note that the City of Virginia Beach must be named as Additional Insured on your Certificate of Insurance.

In addition to the foregoing, I agree to be financially responsible to the City of Virginia Beach for damage caused to the Boat Slip or to City-owned equipment as a result of my negligence or intentional misconduct.
