

## CURRENT STATUS - STAY INFORMED SHORE DRIVE PHASE III (100381)

- Contract Notice to Proceed = May 1, 2025
- Contract Completion Date = Oct 12, 2028
- Current Activities
  - Erosion control measures
  - Shop drawing review
  - Material approval/procurement
  - IT Fiber and Lighting conduit
  - 16" DI water main
  - 12" DI sanitary sewer force main
  - Temporary traffic signals
  - Dominion, Verizon, & Cox relocations



## PROJECT SCOPE SHORE DRIVE PHASE III (100381)


- 1.2 miles of new road with curb and gutter from Vista Circle to Beech Street
- Reduced travel lane width (11') to help reduce traffic speeds
- Raised medians with landscaping/hardscape materials
- 5-foot-wide on-street bike lane
- 8-foot-wide concrete sidewalk, except between Lesner Bridge and Jade Street
- 10-foot-wide shared-use path from the Lesner Bridge to Jade Street to provide a connection to the Cape Henry Trail
- New drainage pipes and structures






## PROJECT SCOPE SHORE DRIVE PHASE III (100381)


- Property entrances consolidated and oriented to the side streets where practical
- Raised roadway profile to address areas of known flooding
- Overhead utilities will be relocated and placed underground at the intersections to improve visibility and aesthetics
- New streetlights and upgraded traffic signals with mast arm signal equipment
- Stamped asphalt crosswalks and improved signage
- Landscaping between the curb and the sidewalks





