#### **Executive Summary**

During the fiscal year covering the period of July 1, 2024 – June 30, 2025 the Historical Review Board volunteers and liaisons

met eight (8) times.

Our most significant accomplishments are detailed below, along with recommendations for your consideration.

#### **Mission Statement**

The mission of the Historical Review Board is to preserve the City's local Historic and Cultural Districts for the benefit of present residents and future generations through the performance of duties as set forth in Article 13 of Appendix A of the Virginia Beach City Code.

## **Accomplishment of Goals and Objectives**

Over the past fiscal year the agency, through its appointed volunteers and liaisons, worked on the following key matters in furtherance of its mission:

- 1. Certificate of Appropriateness (COA) applications considered:
  - a. 15 COAs were issued.
  - b. 1 COA denial was issued for an application after-the-fact.
  - c. 4 projects were approved via a Staff Exception.

- 2. Wrote and submitted two (2) letters of support to the Virginia Department of Historic Resources for Virginia Landmarks Register (VLR) and National Register of Historic Places (NRHP) nominations and nomination updates:
  - a. 1 letter of support was submitted for a VLR and NRHP nomination
    - a. 37<sup>th</sup> Street Cottage Historic District (listed VLR 3/20/2025; NRHP 5/19/2025)
  - b. 1 letter of support was submitted for four (4) VLR and NRHP nomination: updates (including additional information and boundary decreases {2})
    - a. Keeling House (approved VLR 12/12/2024; NRHP 3/10/2025)
    - b. Lynnhaven House (approved VLR 12/12/2024; NRHP 4/3/2025)
    - c. Pembroke Manor (approved VLR 12/12/2024; NRHP 5/09/2025)
    - d. Francis Land House (approved VLR 12/12/2024; NRHP 5/19/2025)
