Staff Reports

- Notice to proceed was issued at Chubb Lake
- Bids opened for Elizabeth River wetland and floodplain restoration
- Noth Lake Holly 1C bid came in at \$3.3 million which was less than the engineers estimate of \$3.9 million.
- \$7 million grant from the Community Flood Preparedness Program for Bow Creek phase 2 was awarded. Which was the maximum award possible.
- Total grants received is \$73 million.

PCSWMM Master Model

- The stormwater master model is the foundation of the work being done.
- The SWMM shows all the pipe sizes, pump stations and tide gates across the board.
- The stormwater master model has had a tremendous evolution.
- In 2015 the survey crew started going out and surveying structures.
- A comprehensive model now has nearly 36,000 nodes and 53,000 conduits.
- The model includes various drainage systems and is calibrated using real flood data to ensure accuracy.
- A new version of the model is being developed to include smaller pipes for greater detail.
- Since 2020 the city has received approximately 333 model requests from developers.





- These models are necessary for projects exceeding 20,000 square feet of impervious area, and developers must submit a list of changes made to the model for review.
- These requests typically come from public and private development projects, not individual homeowners.

Future Construction and Site visits

- Eastern Shore Drive will begin in late December of early January, offering a variety of projects to observe.
- Elizabeth River project is out for bid with work expected to start next year.
- It was proposed to visit sites where new drains and road work are being completed to better understand the project's scope.

Key questions proposed by board members

- What is the estimated cost for the Lake Bradford and Chubb Lake Projects?
- Are there any sites available to observe ongoing construction projects?
- What is the timeline for the completion of the South Plaza Trail Project?
- What is the timeline for the Elizabeth River project to begin construction?
- What are the specific projects that will be completed in the upcoming year?
