### **Discussion Items**

### Welcome, Agenda, and Objectives

- 1. Chair Pocta called the meeting to order at 9:05 am and welcomed everyone to the fourth Stormwater Advisory Group meeting. He emphasized the importance of maintaining an attitude of collaboration and openness to healthy discourse, acknowledging that there may be more disagreement as the group begins to define concrete recommendations. Chair Pocta reminded members of the scope of the advisory group as well, noting that they are not tasked with solving all of the stormwater issues that the City faces.
- 2. Chair Pocta thanked City staff for their attendance, input, and expertise, noting that the Advisory Group will increasingly rely on, and defer to, the City staff expertise as they are subject matter experts.
- 3. Chair Pocta introduced Mike Mauch, Planning Commission Member, as a new non-voting member of the Advisory Group and the liaison for the City Planning Commission. Mauch replaced George Alcaraz, who recently stepped down from the position.
- 4. With the addition of a new member, the members took turns introducing themselves and their respective affiliations.
- 5. Julie Brenman, of Fountainworks, then reviewed the group's scope of work, roles, and expectations.

### **Presentations: Information Requests**

- 1. William "Billy" Almond, Principal Landscape Architect at WPL, a local landscape architecture, land surveying, and site engineering firm, presented ideas on how the City can incorporate more green infrastructure solutions into stormwater standards, as well as what a recent study by Virginia Tech could inform about the practicality of trees as a stormwater Best Management Practice (BMP).
- 2. Emily Archer, Economic Development Deputy Director, presented on the Virginia Beach Development Authority (VBDA) business park stormwater facilities.

### **Rethinking Regional BMPs: Small Groups and Large Group Discussion**

Advisory Group members discussed the role of regional BMPs in addressing stormwater management. Participants first discussed in small groups before moving on to a full group discussion. Members discussed appropriate sites for regional BMPs, ownership, funding sources, and environmental benefits and concerns related to BMPs.

### **Full Group Discussion: Refining Recommendations**

As the meeting was behind schedule, members combined the "Temperature Check" activity (see meeting

**agenda**) with the refining recommendations discussion. As a large group, the Advisory Group reviewed each draft recommendation one at a time.

### **Next Steps**

Julie Brenman reminded the Advisory Group that the next meeting will be held on Friday, August 29, 2025, from 9:00 am to 1:00 pm at City Hall, Building 1, Room 1009, 2401 Courthouse Drive, Virginia Beach, Virginia. Brenman also informed members that Fountainworks would work closely with staff to revise the recommendations based on the day's discussion and share the new drafts prior to the next meeting.
